

## OFFICIAL RULES

**NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING. Odds of winning will depend on the number of eligible entries received.**

**The Cincinnati Bar Association, 225 E. Sixth Street Cincinnati, OH 45209 (“CBA”), will conduct the CBA Like It To Win Sweepstakes (“Sweepstakes”) substantially as described in these Official Rules (“Rules”). The Sponsor for the Sweepstakes is Lexis Nexis (the CBA and Lexis Nexis will be collectively referred to as “Sponsors”). Participation in the Sweepstakes constitutes entrant’s full and unconditional agreement to, and acceptance of, these Rules. This Sweepstakes is an advertising promotion and may be temporarily postponed or discontinued at any time without prior notice. This Sweepstakes is in no way sponsored, endorsed, or administered by or associated with Facebook.**

1. **How to Enter:** No purchase is necessary to enter the Sweepstakes. To enter, send your name, address, and telephone number to Cincinnati Bar Association, 225 E. The Sweepstakes will begin on Wednesday, Sept. 7 2016 at 10:00 a.m and end on Wednesday, Sept. 7 2016 at 11:59 p.m. Limit one entry per person. No copies, facsimiles, or mechanical reproductions will be accepted.

Illegible and incomplete entries are void. Sponsors are not responsible for lost, late, mutilated, postage due, misdirected entries or entries not received regardless of cause. Only one registered account per entry. If multiple accounts are detected for a single entrant, the accounts will be voided and the entries will be disqualified in Sponsors’ sole discretion. In the event of a dispute over who submitted an online entry, the entry will be deemed to have been submitted by the authorized account holder of the e-mail account associated with the social media account used to submit the disputed entry.
