Judge Joseph D. Johnson was appointed to the bench in 2005. He was the first African-American to be appointed a judge in Shawnee County, as well as the first black public defender in the State of Kansas. He is a graduate of Winston-Salem State University (NC) and KU Law School. For 30 years he practiced law both as a public defender and privately. The judge teaches at the National Criminal Defense College, the Trial Advocacy Institute and the Intensive Trial Advocacy Program. Memberships include the National and State Criminal Defense Lawyers, the American College of Trial Lawyers and the American Board of Criminal Lawyers.
